## **Northdown Country Riding Club Terms & Conditions**

1. Riders must keep to marked tracks only.
2. Hard hats conforming to BS EN 1384 or PAS015 must be worn by all mounted riders at all times.
3. Please respect other riders on the farm. Any riders found to be riding in a way which could endanger themselves, their horses or other riders will be asked to leave.
4. No vehicles, pedestrians or dogs are allowed except in the designated parking areas.
5. NCRC tags and keys must be carried by all riders at all times. These are not transferable. Riders using the farms without identification will be asked to leave immediately.
6. Please note some tracks especially through the wooded areas may be roped off during the winter months; please respect these restrictions as it is simply to preserve the tracks for the summer riding. Anyone found riding in areas which have been restricted will be asked to leave the farm.
7. Please be aware whilst you are riding that there are some rabbit holes on the farm. Every effort is made to mark these clearly with posts for your safety but please keep a look out at all times. If you find fresh holes which aren't marked please let us know either via Speedgate Feed Barn or email NCRC Admin: [info@northdown-riding.co.uk](mailto:info@northdown-riding.co.uk).
8. The keys remain the property of Northdown Country Riding Club and should be returned on request.
9. All gates must be kept shut and locked at all times immediately after use.
10. Damaged jumps must be reported to Speedgate Feed Barn or to NCRC Admin on 01474 888474 or email [info@northdown-riding.co.uk](mailto:info@northdown-riding.co.uk).
11. Farm machinery should be given priority at all times.
12. All adult members must be over 17. Family membership is open for up to 2 adults and up to 3 children, provided they are all living at the same address.
13. All riders under the age of 17 MUST be accompanied by an adult member at all times.
14. Guest members must purchase a day pass from Speedgate Feed Barn prior to their ride and MUST be accompanied by an adult member. Please note if riders wish to ride on Sundays the pass must be purchased before the Feed Barn closes at 4pm.
15. The management reserves the right to close the rides at any time without prior notice.
16. The management reserves the right to refuse or withdraw membership without stating a reason.
17. The management makes every effort to ensure the safety of all jumps and rides. However, members are reminded that Riding is a HIGH RISK sport and all activities are undertaken at their own risk and are advised to carry their own Horse & Rider liability insurance.
18. All members and other riders are required to maintain their own Horse & Rider liability insurance at all times when using the course.
